Dear Mare Owner:

We are sorry that your mare is not expecting a 2012 foal and would like to provide you with this information packet to facilitate your rebreed. There is a simple one page form enclosed for you to fill out and return to us. This form is your opportunity to advise us about when you plan to breed your mare, whether you plan to bring her to DeGraff Stables at Liberty Farm for a Haul-In insemination, or, whether you prefer to have us ship semen to you. And, of course, the form provides us an opportunity to have you to update all of your contact information such as to mailing and shipping addresses, phone numbers and credit card information for our files.

If you choose to bring the mare to the farm for a Haul-In insemination, please indicate by checking the appropriate box. We will then mail you the proper paperwork so that we will be able to obtain appropriate Health Certificate and Coggins copies for our records prior to entry to the farm.

In addition to the one page 2012 Rebreed form, we will need the following sent to DeGraff Stables at Liberty Farm to complete our records and to process your breeding:

- 1) Copy of mare's registration papers (if mare is a substitution and papers are not previously on file)
- 2) Copy of veterinarian's statement for reason for rebreed
- 3) Copy of negative uterine culture with sensitivity and cytology current within 30 days is required for all open mares.
- 4) If you are substituting a mare, please advise us of this on the form and again, we will need a copy of her registration papers.
- 5) Please enclose the payment to "DeGraff Stables" for the \$250 Rebreed Fee. This includes the initial collection fee. If you are rebreeding for a color guarantee, other fees may apply to the stallion owner per your original contract.
- 6) If you bring the mare to the farm for a Haul-In insemination, the fee is \$215 plus 6% Sales Tax and includes the collection.
- 7) If we are shipping semen, these fees; \$175 CPU, \$250 FedEx, \$25 Additional for Saturday Delivery or \$350 for Airline plus any applicable Sales Tax, will be charged to your credit card at the time of shipment.
- 8) If for some reason you do not have a 2011 (previous year) Shipped Semen Contract in place, you will need to execute a 2012 Shipped Semen Contract in addition to the 1 Page Rebreed Form.

DeGraff Stables at Liberty Farm does require an up-to-date valid, credit card available to charge for shipping fees as they are incurred and to provide for your Equitainer deposit. Any rebreed, booking or, breeding fees may also be charged to your card if you so choose, or, you may send a check. If your rebreed is for a Kentucky eligible foal, again, a 6% sales tax will apply. A 3% convenience fee will apply to all credit card charges.

As an alternative to providing us with a credit card for shipped semen fees, you may prepay for these services by check, cash, or money order. If pre-paying, please have a minimum of \$600 paid toward your account in advance of requesting a shipment. We will promptly return any unused fees when your mare is safely in foal.
